### Circular No. RP/2019-02

To: All Pesticide Registrants,

Dear Sir/Madam,

### Strict Adherence of Product License Conditions: Import of Pesticides Registered under the Control of Pesticides Act No. 33 of 1980

Registration & importation of pesticides are highly regulated subjects under the Control of Pesticides Act No. 33 of 1980. Each and every import consignment is strictly monitored & regulated to make sure strict quality control & official channels are maintained. It is also assured that continually imported & marketed pesticides are in consistent with data ownership & integrity of data and do not pose unreasonable adverse effects on human health and the environment. Regulatory assumption is that every import consignments of registered products are identical to the originally declared pesticides under Section 6(1) (a) *as meeting the same identity, quality, efficacy, safety & regulatory standards.*

In this regard, in order to maintain strict quality control of pesticides, *all pesticides registered under the Control of Pesticides Act No. 33 of 1980 are authorized to import only from the declared channel/sources as per the license issued on individual pesticide products.* I have made to understand that some indenting companies operate as regular business/invoicing/trading agents on behalf of or other than the exact material supplier/country of origin. Therefore, in order to capture the alternate billing/invoicing/trading agents, the current *Application for Import of Pesticides* is hereby amended by inclusion of the following additional field to read as:

“4.3 Billing/Invoicing/Trading Agent (if different from 4.2)”

Please be informed that the Controller General of Import & Export has been requested & will be maintaining strict vigilance on import conditions & checking on official channels (manufacturer/formulator & the supplier) in order to maintain necessary legality of pesticide products imported into the country.

The above decision will immediately be reflected in *Certificates of Registration* issued on such products. I hasten to request from you to submit original *Certificates of Registration* for necessary amendments, if any party has been affected by this decision, with required proofs of documents. The amended *Application for Import of Pesticides* is enclosed herewith for your information & necessary action.

- The Application will be rejected if required information is not provided on any of the above items or found to be incorrect or satisfactory Quality Certificate is not submitted for the last consignment imported.
- No person shall import any consignment manufactured/ formulated prior to 3 months that of the date of shipment.
- Consignment imported should strictly be conformed to details provided under 4.1 and 4.2 of this application. Any deviation is not allowed unless prior approval has been obtained.
